MOTION was made by FERGUSON and was supported by LUTZE to accept the minutes of the last meeting.

MOTION was made by RAY and was supported by HEMINGWAY to pay all bills and draw warrants for same.

MOTION was made by HEMINGWAY and was supported by LUTZE to adopt Budget Amendment No. 2013-07 in the amount of \$1,734.18 to cover MDOT's payment by transferring funds from Village Improvement to DPW Contracted Services.

MOTION was made by RAY and was supported by PRICE to approve the Blue Cross Blue Shield Insurance rate increase, 7.44%, from \$567.10 to \$609.30, \$42.20 each employee to begin May 1, 2013.
