## **Regular Meeting**

March 16, 2020

Meeting was called to order by President Jeff Lutze at 7:02 p.m. in the Tom Bess, Jr., Council Chambers.

DISCUSSION: The final inspection has been done on 302 W. Main Street. We will communicate with 139 S. State Street regarding blight. Bob sent letters out to individuals who needed to comply with the Village Ordinances. We are currently in the process of updating the ordinance on rental inspections.

The Village office will be closed to the public. The letter is posted on the door of the Village office, due to the State of Emergency situation with COVID-19. To keep the Village residents informed we will post signs in the Post Office, Facebook, the website and local businesses. The police will be dispatched if needed. Matt stated that if his officers come in contact with a person who is quarantined, then his officers will be quarantined for 2 weeks. The State/County will handle the COVID-19 protocol setup.

The Budget Amendment should be done the beginning of each month. Dan explained the Budget Amendment in detail. The DR is a debit, which increased the amount for the revenue accounts. The CR is a credit, which decreases the amount. The "expense accounts are opposite" the DR/debit decreases and the CR/credit increases the amounts. The first set of numbers of the GL are the fund, i.e., 101 General Fund, 441 DPW Fund. The 2<sup>nd</sup> set of numbers "000" shows revenue. The 2<sup>nd</sup> set also shows the departments, i.e., 215 Clerk, 253 Treasurer, 441 DPW. The 3rd set of numbers are the account, i.e., 402 tax levy, 728 office supplies. Dan has entered the actual description on the Budget Amendments to better understand the number system on the Budget Amendment Report. Dan will meet with the respective Council Member regarding the 2020/2021 Budget. The Police tentative budget for 2020/2021 has increased by \$11,000.00. The Audit will be completed by April 20, 2020. The Budget is due in May 2020. Police Officers will receive a \$2.00 an hour increase. This is to bring their pay more in line with other communities. Other increases for the Police Department are for the Core Tech., and IT Rights. The IT Rights will prevent internet hacking and will have border protection, which will help maintain daily office functions. Consumers Energy wants to raise the rates starting March 23, 2020. The penalty of \$700.00 to transfer the CD's from Huntington to Elga was removed before the transfer took place.

The Levy for Mass Transit is in the mileage.

Randy Enicks, Rick Ferguson and John Ray will need to run for their Council member positions by July 21, 2020.
