We are waiting on mulch to arrive to finish Memorial Park. MaryAnn informed us we have to wait for the CBGD money, as it needs to go out to bid. We are going through the formality. Eastern, Chippewa and Ace will have to resubmit their bids. The two low lift pumps at the Lagoon are 41 years old; they need to be replaced, as these pump out to the fields. We are waiting on new pumps to arrive.

Jeff Lutze - Due to COVID -19, watch Village spending. Should we cancel the car shows? It was discussed that due to the car show being outside and you can socially distance; not to cancel the car shows at this time. The August 22nd, Block Party may be canceled due to COVID-19. This will be decided on the next Council Meeting on July 20th. Wait on sending out the liquor license. Why was M-15 closed at 57? It was closed to replacing a culvert. What is going on with the Sand Separator? It is currently not done; it is our next project to complete.
