

Ordinance No. 102

An ordinance to adopt by reference amendments to the Uniform Traffic Code for Michigan cities, townships and villages.

The Village of Otisville ordains:

Sec. 1. AMENDMENTS TO CODE ADOPTED

The Uniform Traffic Code for Cities, Townships and Villages, and the amendments to such Uniform Traffic Code as adopted by Ordinance No. 92 of the Village of Otisville all of which was promulgated by the Director of the Department of State Police, effective January 27, 1981 and published in Quarterly Supplement No. 5 of the 1979 edition of the Michigan Administrative Code, in accordance with Act No. 62 of the Michigan Public Acts of 1956, is hereby amended to include the terms and provisions of Sections 2.5a, 2.5b, 2.5c, 2.5d, 2.5e, 2.5f, 2.5g, 5.15, 5.15a, 5.15b, 5.15c, 5.15d, 5.15e, 5.15f, 5.15g, 5.15h, 5.15i, 5.15j, and 5.82, all of which amended and added Sections are available for inspection by members of the public at the Village office located at East Street, Otisville, Michigan during regular office hours; and any and all sections of the Uniform Traffic Code for Cities, Townships and Villages heretofore adopted by the Village of Otisville which are inconsistent with the said adopted sections are hereby revoked.

Sec. 2. NOTICE TO BE PUBLISHED

The Village Clerk shall publish this ordinance in the manner required by law and shall at the same time publish a supplementary notice setting forth the purpose of the Uniform Traffic Code and of the fact that a complete copy of the code as hereby amended is available at the office of the Clerk for inspection by the public at all times.

Sec. 3. APPROVAL AND PUBLICATION.

This Ordinance was approved by unanimous vote of the Village Council, a quorum being present on April 4, 1983, and ordered published in three public places in the Village of Otisville within ten (10) days after its adoption.

Sec. 4. DATE OF EFFECT

This ordinance shall take effect and be in full force and effect twenty (20) days after passage by the Village Council, said effective date being April 24, 1983.
