Sec.1. CODE AND AMENDMENTS AND REVISIONS ADOPTED

The Michigan Vehicle Code, 1949 PA 300, MCL 257.1 to 257.923, and all future amendments and revisions to the Michigan Vehicle Code when they are enacted and effective in this state are incorporated by reference.

Sec.2. REFERENCES IN CODE

Sec. 3. NOTICE TO BE PUBLISHED

The village clerk shall publish this ordinance in the manner required by law and shall publish, at the same time, a notice stating the purpose of the Michigan Vehicle Code and the fact that a complete copy of the Code is available to the public at the office of the Clerk for inspection.

Sec. 4. PENALTIES

The penalties provided by the Michigan Vehicle Code are adopted by reference

Any and all ordinances inconsistent with this ordinance are hereby revoked.


Sec. 6. APPROVAL AND PUBLICATION






