ORDINANCE NO. 9/

THE VILLAGE OF OTISVILLE ORDAINS:

AN ORDINANCE RELATIVE TO ENTRY UPON LANDS OF ANOTHER AFTER HAVING BEEN FORBIDDEN TO DO SO; REFUSAL TO DEPART THEREFROM.

SECTION 1.

Any person who shall wilfully enter, upon the lands or premises of another without lawful authority, after having been forbidden to do so by the owner or occupant, agent or servant of the owner or occupant, or any person being upon the land or premises of another, upon being notified to depart therefrom by the owner or occupant, one agent or servant of either, who without lawful authority neglects or refuses to depart therefrom, shall be guilty of a misdemeanor and upon conviction thereof shall be punished by imprisonment in the county jail for not more than thirty (30) days or by a fine of not more than One Hundred (\$100.00) Dollars, or both, in the discretion of the court.

SECTION 2. DATE OF EFFECT.

This Ordinance shall take effect and be in full force and effect twenty (20) days after its passage by the Village Counsil, said effective date being \_\_\_\_\_\_, 1979.

SECTION 3. APPROVAL AND PUBLICATION.
