# VILLAGE OF OTISVILLE OBSTRUCTION OF STREETS Ordinance No. 9

An Ordinance relative to obstructing, incumbering and approaching upon streets, lanes, alleys and highways of the Village.

The Village of Otisville Ordains:

### SECTION 1:

That no person shall obstruct or incumber any street, lane, alley or highway of the Village of Otisville, by placing or allowing to be placed or to remain thereon, any building, lumber, timber, wood or other material or substance.

### SECTION 2:

No Building, fence or other structure in said Village shall be constructed, extend into or in any manner encroach upon any street, lane, alley, or highway of said Village; and no such encroachment heretofore constructed in or extending into any such street, lane, alley or highway, shall be allowed to remain therein by the owner occupant thereof, or the person causing same. If any such encroachment is now or shall be hereafter constructed in or extended into any such street, lane, alley or highway, as aforesaid, the Superintendent of Public Works or Village Building inspector shall, on the order of the Village Council, deliver to the owner or occupant thereof, or to the person causing such encroachment, a written notice specifying the location and extent of such encroachment, and requiring such person to remove the same within thirty days from the service of such notice; and if no such owner or occupant can be found in said Village, such notice may be served by posting the same conspicuously upon such encroachment. If such encroachment shall not be removed within the time specified in such notice, the Village Building Inspector shall remove the same, using such force as may be necessary or reasonable for the purpose. But proceeding under this section shall have no effect upon the liability of any person to the penalty prescribed in the next.

### SECTION 3:

Any person who shall obstruct, incumber or willfully encroach upon any street, lane, alley or highway of said Village, or who shall have obstructed, incumbered or willfully encroached upon such street, lane, alley or highway, in the manner aforesaid, and shall allow such obstruction, incumbrance or encroachment to remain thereon, shall be punished by a fine not exceeding \$100.00 dollars and costs of prosecution, and may be imprisoned in the County Jail or until such fine and costs are paid, not exceeding 90 days. Every day during which such obstruction, incumbrance or encroachment shall be allowed to remain and exist shall constitute a separate and complete offence under this Ordinance.

## SECTION 4:

Any obstruction of the streets, lanes, alleys or highways of said Village, may be removed by any officer or servant of said Village without any notice to any person or any process at law, but this section shall in no-wise effect either of the foregoing sections or this Ordinance.
